<u>02.418.009:</u> Consideration of Interim order in WP (C) No.31418 of 2024 dated 10.09.2024 passed by the Hon'ble Hon'ble High Court of Kerala filed by The Kunhitharuvai Memorial Charitable Trust Vs Pharmacy Council of India & Ors.

- 9.2 It was noted that
 - a) Hon'ble High Court of Kerala has issued an interim order in WP(C) No.31418 of 2024 titled KMCT Medical College Camus Vs. PCI dated 10.09.2024 directing the PCI not to reject the application to start B.Pharm and D.Pharm courses and further process the application for approval of B.Pharm and D.Pharm courses without insisting the NOC of the State Government pending disposal of the writ petition.
 - b) similar order was passed in W.P No.31421 of 2024 titled KMCT, KMCT Medical College Camus Vs. PCI and Ors. dated 10.09.2024 directing PCI the PCI not to reject the application to start B. Pharm and D.Pharm courses and further process the application for approval of B. Pharm and D.Pharm courses without insisting the NOC of the State Government pending disposal of the writ petition
 - c) the KMCT institute of Pharmaceutical Education and Research and KMCT Institute of Pharmacy have applied for the conduct B. Pharm and D.Pharm for the academic session 2024-25.
 - d) the institutions have submitted the Consent of Affiliation of Examining Authority for B.Pharm course earlier on 31.05.2024 and Government of Kerala vide Order dt.20.09.2024 have issued NOC to start B.Pharm course at KMCT Institute of Pharmaceutical Education and Research with 60 seats and KMCT Institute of Pharmacy with 60 seats which is after due date as decided by 416 EC (20th & 21st September, 2024).
- 9.3 In view of above, it was decided as under
 - a) To honour order dated 10.09.2024.
 - b) To arrange inspection of the institutions only for B.Pharm course and for D.Pharm course, it was decided to reject the application of the institution as failed has to submit Consent of Affiliation of Examining Authority even after according ample opportunities.
 - c) To file appeal against the view taken by the Hon'ble Court.
