This is in compliance with the order dated 19.12.2024 passed by the Hon'ble High Court of Judicature at Allahabad (Lucknow Bench) in Writ-C No. 11186 of 2024 and other connected matters, it is informed that your application cannot be considered at this stage due to the cut-off date of 10.12.2024 set by the Hon'ble Supreme Court of India stands over.

As per the Supreme Court's directive, applications received after this date cannot be processed for the academic year 2024-2025 unless specific prior permission granted by the Hon'ble Supreme Court.
