	<p><b>Clarification regarding decision dated _____ for 2024-2025 academic session-</b></p> <p>This is to inform you that the Council has received several representations concerning the academic continuity of students studying in institutions that were not granted approval for admissions in the academic session 2024–25.</p> <p>After careful consideration of the matter, the Council has decided to grant approval for the continuation of running courses, despite the rejection communicated to your institution through the PCI portal on _____, which pertained exclusively to new admissions for the academic session 2024–25.</p> <p>It is to be noted that the said rejection does not affect the continuation of the existing pharmacy course for the academic session 2024–25, subject to the submission of an undertaking by the institution confirming the availability of the required physical and academic infrastructure.</p> <p>The intent of this decision is to ensure compliance with the prescribed norms while safeguarding the academic interests of existing students, whose ongoing education remains unaffected.</p>

- b) to seek clarification from those institutions who applied during 2024-2025 academic session and inspection was arranged, institution was granted approval based on inspection report but not applied to PCI during 2025-2026 academic session.
- c) to inform the State Government that if any new or existing institution applied for a new course or increase in intake during the 2024–2025 academic session, and the application was rejected after inspection, and the institution did not apply to PCI for 2025-2026, then any students admitted in such unapproved courses shall be shifted to approved institutions as per PCI migration guidelines.

Scheduled on 10 to 17th April 2025 with two inspectors from UP Dr Pranay Wal BH-P-23-32718 and Dr Kritika Sachan BH-P-23-32718. But before we plan the authority from the Institute has forwarded letter to us and pci registrar regarding non acceptance of inspection as their Institute is undergoing some litigation issue with Government and inconvenient for our visit.

16.3 In view of above, it was decided to seek data of last 5 years of registration done by all State Pharmacy Councils in respect of those students who have passed from CMJ University in google form. On receipt of the data from the State Pharmacy Councils, same be verified by Examining Authority.
