1. *In these batch of matters, notice was issued by this Court and Mr. Ajay Kumar Singh, learned counsel appearing on behalf of respondent/PCI had sought time to seek instructions.*
2. *He has returned with instructions to the effect that all the petitioner colleges in the present batch of matters can furnish an affidavit stating that they will fulfill all the requirements as per the Regulations.*
3. *He submits that once such an affidavit is furnished by the petitioner colleges, their cases will be considered afresh by the Executive Committee in its meeting scheduled to be held on 26.09.2025.*
