Sub: **Registration and Submission of Application form on PCI portal for Examining Authority U/s 12(2) of the Pharmacy Act, 1948.**

Sir/Madam,

With reference to the subject cited above, council would like to inform that all the Examining Authorities (Universities/Boards) needs to register and apply on the PCI Portal on the immediate basis on the following URL i.e. <https://digipharmed.pci.gov.in/#/digipharmed> under “Examining Authority Registration” section.

The University/Board are hereby instructed to register on PCI Portal as Examining Body u/s 12(2) of the Pharmacy Act, 1948 for approval by all the Examining Authorities (Universities / Boards). Examining Authorities (Universities / Boards) shall apply for renewal of approval after every 5 years.

However, the necessary details regarding examination schedules/calendar, list of institutions for which consent has been given by the institutions etc. needs to be updated regularly/yearly after the approval from Pharmacy Council of India.

The list of necessary statutory documents that are required to be added by the Institutions is attached as **Appendix 1**.

In addition, the fees schedule for this are as under:

- Registration fees for the Examining Authorities (Universities / Boards): Rs. 10,000 + GST (Ten Thousand Rupees + GST)
- Application Regulatory Fees: The applicable fees will be Rs. 1,00,000 + GST (One Lac Rupees + GST) for the tenure of five years.

The portal will be live from 21.1.2026 and All the Examining Authorities (Universities / Boards) are requested to complete the same on or before 21.2.2026.
