This is in reference to the above subject matter where all concerned stakeholders are hereby informed regarding the following important modification/changes and updates from the Pharmacy Council of India (PCI) in respect to the digital platform.

## 1. Modification of URL/Web address in the Official Website of PCI

It is important to note that the Pharmacy Council of India's official website has changed from www.pci.nic.in to www.pci.gov.in. All official information, notices, and updates will be made available on the new website from now onwards (www.pci.gov.in).

### 2. New features under Grievance Redressal Module

All the users are hereby informed that issues/grievances should be reported only through the Digi-Pharmed portal for the sections specified in the "Grievance Module". Therefore, you are requested to log in to the Digi-Pharmed portal to raise and track your grievances instead of e-mail communications to the council.

## 3. Username Retrieval Facility for Students and Pharmacists

Pharmacists and students who have forgotten their login credentials can now retrieve their username by clicking on "forgot username" on the login page or via this link.

https://digipharmed.pci.gov.in/#/forgotusername and follow the steps as mentioned below:

- Verifying their personal details i.e. Mobile Number and E-Mail ID registered on the DIGI-PHARMed Portal through the form available on the portal.
- Completing a second-level verification through OTP sent to their registered mobile number.

## 4. Profile Update Facility for Pharmacists

Pharmacists can now update the following details directly through the **Profile section** in the Digi-Pharmed portal:

- o Basic Information (Name, Address etc.)
- Educational Qualifications
- o Bank Account Details

The profile updating process is protected by OTP-based mobile verification to assure validity and authenticity. Therefore, users should keep their profiles accurate and up to date via this feature.

5. In addition to this, all users are requested to ensure that their mobile number on DIGI-PHARMed portal must be registered with the Aadhar. In case, the same is not verified, then it may lead to blacklisting of such user due to unsuccessful e-KYC in future.

Therefore, all users are hereby requested to take note of these modifications/changes/updates and adhere the updated approaches going forward.
