Sub: Responsibility of the Institutions for error in Scholar details verification for GPAT Scholarship on the Pradhan Mantri Scholarship for Pharmacy Post Graduate Studies (PMSPPS) portal – reg.

Ref.: Council's Circular No. 14-401/2025-PCI/ 5163 dt. 26.11.2024 ltem No. 22 of 425/EC (25.4.2025)

Sir/Madam,

With reference to the subject cited above, it is informed that the Council has already started disbursing the scholarship to the qualified scholars. In this connection, all institutions are hereby directed to comply with the following points as under:

"In the event that any misleading information is identified in the credentials or verification details of scholars on the PMSPPS portal, or in cases of duplicity involving the receipt of grants for scholars under multiple schemes, the concerned institution shall be held liable for the recovery of disbursed funds for the respective scholars and approval will be withdrawn."

It is further informed that, in case of any errors, discrepancies, or misrepresentations be discovered in the submitted records whether arising from oversight or otherwise the institution will be held solely accountable for the same. This includes, but is not limited to, inaccuracies in academic records, enrolment data, financial information, and other official documentation related to the scholar.

Furthermore, institutions are required to provide permanent and official email addresses and contact numbers for both the maker and the checker involved in the verification process. Temporary, personal, or frequently changing contact details are not acceptable. Kindly note that repeated requests for edits or changes to contact information will not be entertained by the Council once the data has been submitted. This measure is being enforced to ensure traceability, accountability, and to avoid administrative inefficiencies.
