Pre-Qualification and Technical Evaluation of Tender ID – 2023 PCIn 724253 1, "Supply of Apple MacBook" Tender

This is in ref. to Tender ID – 2023_PCIn_724253_1, "ToR for Supply of Apple MacBook" which was floated on Central Public Procurement Portal (e-publishing) dt. 22.08.2023 and subsequent corrigendum dt. 30.08.2023. The ToR and corrigendum were also uploaded on PCI website (https://pci.nic.in/) along with publishing of advertisement for procurement of Apple MacBook in leading newspapers (Times of India, The Hindu and Hindustan Times) after approval from competent authority.

The technical bid opening meeting was held on 05.10.2023. The Council had invited bidders to technical bid opening meeting via email dt. 04.10.2023. M/s. Nice Infotech informed the Council about not being able to attend the meeting vide email dt. 04.10.2023. Additionally, vide email dt. 05.10.2023, M/s. Anant Vision Technologies informed that it will not be able to attend the meeting and has no objection to opening of bid in its absence. M/s. Agmatel India Pvt. Ltd., M/s. Technify Solutions Pvt. Ltd. and M/s. Datalogics India Pvt. Ltd. did not respond to the Council's email in this matter. Furthermore, M/s. Radius Systems Pvt. Ltd., M/s. NF Infratech Service Pvt. Ltd. & M/s. Icon Power Solutions Pvt. Ltd. attended the meeting and the technical bids of all the bidders were opened in the presence of aforementioned bidders and evaluation committee.

M/s. Icon Power Solutions Pvt. Ltd., M/s. Radius Systems Pvt. Ltd., M/s. NF Infratech Service Pvt. Ltd., M/s. Technify Solutions Pvt. Ltd. & M/s. Datalogics India Pvt. Ltd. were found to be qualified for technical qualification evaluation.

M/s. Nice Infotech was disqualified as it did not fulfil PQ4 (Non-Blacklisting), PQ5 (Similar Experience), PQ7 (Human Capital Strength) and PQ10 (Warranty Certificate).

M/s. Anant Vision Technologies was disqualified as it did not fulfil PQ1 (Bidder company Registration), PQ3 (Bidder's Average Annual Turnover), PQ5 (Similar Experience), PQ8 (Net worth), PQ9 (Certification), and PQ10 (Warranty Certificate).

M/s. Agmatel India Pvt. Ltd. was disqualified as it did not fulfil PQ10 (Warranty Certificate). The document submitted by the bidder for PQ10, only mentioned Apple's standard warranty i.e., 1 year, however, as per the ToR, "3 Year OEM warranty is must. Bidders need to enclose supporting documents with proposal."

The Council had requested for missing/incomplete documents from all the bidders(except M/s. Anant Vision Technologies as it did not fulfil PQ3 criteria i.e., it had average annual turnover less than 5 crores) vide email dt. 11.10.2023, however, no response was received from M/s. Nice Infotech and M/s. Agmatel India Pvt. Ltd. Whereas, M/s. Icon Power Solutions Pvt. Ltd., M/s. Radius Systems Pvt. Ltd., M/s. NF Infratech Service Pvt. Ltd., M/s. Technify Solutions Pvt. Ltd. and M/s. Datalogics India Pvt. Ltd. had submitted missing/incomplete documents within the specified timeline (13 October 2023, 3:00 pm).
