Sir/Madam,

This is in continuation of Council's Circular dt.30.8.2024.

It is informed that the PCI is in process of completing the approval process for 2024-2025 academic session. The decisions to the existing institutions have been conveyed to almost all institutions as per policy decided by PCI.

For the existing institutions who have applied for introduction of new course and raise in intake for 2024-2025 academic session, the application is under active consideration of the Council. Institutions applied for first time for 2024-2025 academic session, application is also under consideration.

The Pharmacy Council of India will complete the approval process in accordance with timeline fixed by Hon'ble Supreme Court vide its order dated 10.04.2024 in MA No. 704/2024 in CA No. 9048/2012 titled Parshavanath Charitable Trust and Ors. Vs. AITCE & Ors. i.e., October 31st 2024 for completion of approval process and 30th November 2024 for appeals /compliance.

The Council has received various representations from institutions across country that admissions making authority has not started admissions process for those institutions which are already approved by PCI for 2024-2025 academic session.

In light of the above, The Council requests all admission making authority to start admissions process to those institutions which are already granted approval by PCI for 2024-2025 academic session.

This issue is with the approval of competent Authority.
