## To All,

Sub: Notification regarding Issues of Data inaccuracy and duplicacy of registered Pharmacists on the DIGI-PHARMed Portal.

#### Sir/Madam,

- This has a reference to the subject matter cited above regarding the issues identified in the profile data of registered pharmacists on the DIGI-PHARMed Portal.
- 2. In this connection, Council has analysed that many pharmacists:
  - a) Have created duplicate profiles with the same Aadhar Number or PAN Number. In addition, all these duplicate profiles on a single Aadhar Number were found working as a faculty in different institutions.
  - b) Have entered invalid/fake Aadhar or Pan card details during the registration on DIGI-PHARMed Portal. For Example: Aadhar Number having more or less than 12 digits/text type as input in Aadhar Number/Complete numeric entry in PAN Card data/Incomplete PAN Number/Invalid input etc.
  - c) Have not entered the State Pharmacy Council registration number in their profile but working/not working as a faculty in the institution.
  - d) Have not added any educational or experience details in their profiles but working/not working as a faculty in the institutions.
  - e) Many pharmacists have entered invalid Mobile Number or E-mail as well in their account to create the fake profiles on the DIGI-PHARMed Portal.
- 3. Therefore, as per the minutes of 421<sup>st</sup> EC Meeting, Council had decided to blacklist all these registered Pharmacists on the DIGI-PHARMed Portal permanently. If any registered pharmacists are found doing these kinds of activities again, then they will be debarred for the further registration purpose in future on DIGI-PHARMed Portal.
- 4. In addition, it is also notified that the access on the account of all users having no education details filled in their profile will be restricted for any usage.

5. Further, institutions are also informed that during the process of faculty joining, they must check all the necessary details on the DIGI-PHARMed Profile of the faculty to ensure that the profile is updated.

This issues with the approval from the Competent Authority.
