This is in continuation to Councils above cited circulars.

In this connection, it is informed that –

- a) due to technical reasons in the payment processing, some institutions were not able to submit the SIF successfully on the portal.
- b) many institutions were not able to submit the SIF due to the technical concerns or incomplete form details in the SIF for the Academic session 2025-26.
- c) 423/EC in its meeting held on 12.2.2025 has decided to open the portal from 17.2.2025 to 19.2.2025 for the institutions who have not able to submit the PERC and SIF for 2025-2026 academic session.

In view of above, all the institutions are requested not to wait for the last date as crowding may slow down the server, hence application be submitted at the earliest within the stipulated date. The consequences of failure to apply will rest on the institutions as no further extension will be given by the Council.
